The Tahitian Cycling Federation and its 20th Organizing Committee, hereby, send you this invitation to participate in the international event “Tour de Polynésie” to be held in French Polynesia from June 29th to July 4th 2014.

We once again will be honored to welcome you to our stage road race on the islands of Tahiti and Moorea in the aforementioned days.

Therefore, you will find along with this invitation the Official Registration Form which needs to be returned to the federation by mail at ftc@mail.pf or by fax at +689 451091 by Monday, June 9th 2014 along with a non-refundable (but deductible from the overall team’s fees) deposit of 25 000 XPF to be wired on the following bank account:

Other than the round trip flight transportation at your delegation’s charge, the participation conditions hereafter apply:

UCI licences and Insurance, driver’s licence

To be officially in the 2014 Tour de Polynésie:

1. All engaged riders of the 2014 Tour must be 18 years-old and a holder of an UCI International Licence. UCI requirements state that appropriate insurance must accompany the purchase of an International Licence. According to UCI Cycling Regulations relating to International Licences and Insurance (1.1.022) appropriate insurance should include;
 - *Insurance for bodily injury (in and out-patient hospital expenses and medical care, transport costs, permanent disablement, death) and material damages (loss of earnings) in case of accident on the occasion of a cycling competition or during training.*

All engaged riders of the 2014 Tour must provide a copy of both documents to the Organizing Committee: the valid UCI International Licence and the valid appropriate insurance along with Registration Form.

2. An International Technical Licence is required for all team staff (Coaches, Managers, Mechanics and Soigneurs) attending the event. A copy of the International Technical Licence along the valid appropriate insurance must be produced to the Organizing Committee along with Registration Form.

If the team staff is to be an official driver (van, scooter) of the caravan, he/she must be a holder of an international valid driving licence. The Organizing Committee will require a copy of the document along with Registration Form.

Fees

Fees apply to the engaged rider and the technical staff:

Rider engagement fee is set at 25.000 XPF (per rider).

Technical team staff participation's fee is set at 10.000 XPF (per person).

Gas fees per team per van are set at 12.000 XPF and at 6.000 XPF per scooter for the whole Tour.

A non-refundable deposit of 25 000 XPF (deductible from your total team's fees) is to be wired on the bank account stated below when the team confirms its engagement to the event, no later than Monday, June 9th, 2014.
